There is life after the shield

On 17 September 2009 the President of the United States of America Barack Obama announced the decision of changing the plans relating to the antimissile shield program. From the Polish point of view, the main consequence of that decision will be the withdrawal from the plans to build a base in Redzikowo near Slupsk. Poland is considered as a country participating in the new system based on more mobile SM-3 missiles launchers. Yet, they are currently under design and the "Polish" element of the new shield will not be completed for at least 6-8 years.

Military engagement of the US in Europe

German unification and NATO enlargement resulted in moving the borders of the western world. Expanded American bases in Germany partially lost their geo-strategic importance. Shifting the priority areas of engagement (into Iraq, Afghanistan, Far East) and the financial crisis makes the US to rationalise the use of their military potential, keeping at the same time superpower status of the country.
